Declarations by Competitors and Drivers Regarding the Exclusion of Liability

(The English translation only serves as information, the newest German version applies)

- The participants take part in the events at their own risk. They bear sole responsibility under civil and criminal law for any damage caused by them or a vehicle used by them, unless exclusion of liability is hereby agreed. This disclaimer shall become mutually effective with regard to all parties involved as of the submission of the entry form.
- By submitting their entry forms, competitors and drivers waive any claims for any kind of damages that may occur in connection with the events, in particular against Baja-Event GmbH, its partners, their agents, sponsors, suppliers, authorities, race services, and other persons involved in the organisation of the event, the owner of the property, the responsible road maintenance authorities, to the extent that damages are caused by the condition of the roads, paths, surfaces including equipment to be used during the event, and the vicarious and performing agents of all the above-mentioned persons and bodies,
- except for damages resulting from injury to life, body, or health caused by wilful act or grossly negligent breach of duty – even by a legal representative or vicarious agent of the persons excluded from liability - and except for any other damages caused by wilful act or grossly negligent breach of duty – even by a legal representative or vicarious agent of the persons excluded from liability.
- They also waive any claims against other participants (competitors, drivers), other participants' assistants, the owners, registered keepers of other vehicles, and their own competitor, driver (other special agreements between the competitor and the driver shall prevail in this context) and assistants for any kind of damages caused in the context of the racing competitions (un-timed, timed training, qualification training, warm-up, races),
- except for damages resulting from injury to life, body or health caused by wilful act or grossly negligent breach of duty – even by a legal representative or vicarious agent of the persons excluded from liability – and except for any other damages caused by wilful act or grossly negligent breach of duty – even by a legal representative or vicarious agent of the persons excluded from liability.
- This waiver of liability shall apply to all claims irrespective of their legal grounds, including, in particular, claims for damages based on contractual or non-contractual liability and even including claims based on tort. Implied exclusions of liability shall not be affected by the foregoing exclusion of liability clause.
- If an injury occurs or is noticed during the event or if the driver's health has been affected such that the driver's fitness for continuing the race is – permanently or temporarily – questionable, the undersigned – with regard to the security risk also resulting for third parties – hereby releases the doctors in attendance from their obligation to professional secrecy towards Baja-Event GmbH's partners carrying responsibility at the event and said partners' agents.

I hereby acknowledge, and agree to, the terms and conditions of the specification, the rules and regulations, the declaration regarding the exclusion of liability, and Baja-Event GmbH's general terms and conditions applicable to this event and hereby undertake to strictly comply with said terms and conditions. I hereby confirm that the details stated in this entry form are accurate and correct, that I hold a driving licence for the registered vehicle and that the registered vehicle, and all parts thereof, fully comply with the German Road Traffic Licensing Regulation (*Straßenverkehrszulassungsordnung*; "StVZO") and that the registered vehicle is insured. Any drivers who fail to comply with these terms and conditions will be excluded from participation. The participants take part in the event at their own risk and responsibility. They bear sole responsibility under civil and criminal law for all damages caused by them or their vehicle.

Off-Road Safety Instructions – 4nd Baja-Saxonia 2011

Please be aware that the competition will be run on a partly active mining site and requires an exceptional permission by the owner. Driving on the site outside the competition is strictly prohibited. Any infringements noticed by the security guards in charge, will be punished by an order to stay away from the site and by a criminal complaint. Your participation in future events on this site would thereby also be excluded for an unlimited period of time. In addition, the organisation of future Bajas on the proprietor's site would probably be jeopardised by such kind of infringements.
